Treasurer report: this is budget meeting, projected about the same income for 2012, increase on agility, decrease in membership, classes/trials about the same, decrease on May show. If we increase insurance & get trailer expenses will go up. Also have had about \$250 in bounced check fees, roughly \$40/chk. Lost our non profit status due to previous Treasurer. Jason is working to reestablish that. TVKC books will be audited by Melanie Schneider of Schneider & Schilling. Still recovering from past 2 yrs under previous Treasurer.

Susan P – made motion to add line item to class signup sheets that a returned check is a \$50 fee. Ron D  $2^{nd}$ . Passed.

Membership: still getting renewals. Nov 15 is deadline for new membership cards. Currently at +/- 75 members.

Hospitality: nothing to report, was told about Lori K losing Bob, will send card.

Training: getting other misc calls, will be working on next year's class schedule

Electronic Committee: only 3-4 emails bouncing, newsletter went out (Kudos to Ron D)

Correspondence: normal mail

March show: judge panel complete, Ron G stated still need trophy money for toys, non sporting & brace

May Show: working on replacing judges (had 2 cancel/back out)

New Business:

Budget approval: All reports were turned in to Jason.

Agility - wants to add classes so a possible increase there, also \$5k in new equipment May show – estimate about \$1500 profit March show – projected loss of \$500 Herding – no budget, account was not used. Susan P volunteered to be the Board member on the TVKC herding committee Tracking - estimate will break even Suggestion made that next year budgets are due to Treasurer prior to Nov meeting for review.

New trailer to replace Kiwanis and then use current Kiwanis one for storage.

Jason brought up idea of taking \$20k and putting into high yield account.

Discussion on May show ring gates – someone thought it was decided at Nov 2010 meeting to get new gates, Show committee can not override membership. New gates are a capital budget item, not May show budget. Discussion over types, styles, weight, ease of assembly. It was decided that the plastic baby gate style would look best and be easiest.

Sue A made motion that TVKC allocate up to \$6k for new ring gates/stations/etc. Ingrid 2<sup>nd</sup>. Approved (amended to Ron D & Donna being responsible for purchasing)

Kristi D made motion to sell the current ring gates/etc <u>after purchase</u> & receipt of new ones. Sue A second. Approved.

Susan P – motion for Treasurer to look into moving \$20k from savings to a high yield account. Ron D 2<sup>nd</sup>. Approved. (amended to add that Spirit of AK be given preference)

Carole P made motion that TVKC purchase a larger trailer for Kiwanis Building, with cap of \$7500. Sue A  $2^{nd}$ . Approved. (amended to add that Ron D & Jason be in charge of the acquisition)
