Mandate the November meeting for financial plan

Change the Board spending limit to \$500

Add a conflict of interest statement for Board & membership

Standing committees - designate one person to attend Board meetings as appropriate

Do not see need for corresponding and recording secretary to be separate positions

Committees – streamline the list (no judges, no library, form an Obed/Rally committee)

Have not looked at Policies and procedures
