### **New Business**

Tracking Seminar budget- Costs are currently exceeding the approved budget from this fall. The trial is on track to make money, income projected is \$1240. Motion to approve the increase in budget by Jimmie Ricks, Terri Morefield seconds. Total expenses will be \$2,420 versus the \$1,000 budgeted. Motion passes.

Term Limits for board members – change to language regarding term limits for board members. Nicki Stewart would like to add 3 2-year terms to increase ability for current board to be able to stay on and continue the work they are doing. Leslie would like to draft language for this motion and then we can discuss. Sue A. discussed the reasoning behind the term limits. TVKC has a high number of people on the board in relation to the amount of people in the club. We could have 4 officers and some at-large directors. Nicki proposes that we work on the discussion and bring it up at the September meeting. That meeting also involves electing new board members and there is also a process in the bylaws to hold a special meeting. We could hold a special meeting to discuss. To lower the number from 7 to 9 would not require a change of the bylaws. Terri, Sue A., Leslie, Ingrid and Nicki will work on this issue.

Next meeting – May 3<sup>rd</sup>. Membership meeting, place to be announced. This will be an educational meeting also. Pet Awareness Day is a big event, Lisa Vaughn has been appointed the coordinator of that event.
