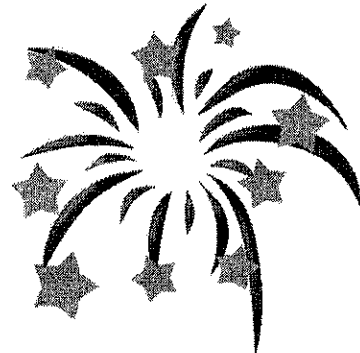

## How to enter an Agility Trial, Terri Morefield TVKC Trial Secretary

Entering an Agility Trial is not difficult once you master the basic information. Always read the Premium List in order to get valuable information like opening & closing date to enter the trial, the trial dates, the judge, if the judge is a measuring judge and the trial fees as well as other basic information for that trial venue. Most trial secretaries send an entry form with the premium. **See above.** Please note the mandatory items that must be completed in order to have a valid trial entry. Failure to provide the information by the closing date of the trial will mean that you don't have a valid entry and may not get to run your dog.

- ✓ In the top section, be sure to mark which classes you want to enter for each day. The DAILY entry fee for the sample attached TVKC entry would be \$55 for the first day, \$55 for the second day and \$35 for the 3d day. This is where the majority of the errors occur with an entry.
- ✓ Choose and circle either Regular or Preferred Classes that you want to enter for you and your dog – be sure to read the AKC Agility Rules & Regulations to verify which class you qualify for. You can only compete in one or the other for the weekend, you cannot mix. If you have competed previously, check the AKC Website to verify your dog's progress toward their title (Instructions how are in a separate section of the newsletter).
- ✓ Indicate whether your dog needs to be measured – you no longer need to include a copy of the jump card with your entry. Again, check the Agility Rules to see if you need to be measured. The premium list will indicate if the judge is a Volunteer

Measuring Official (VMO) or will be measuring for just this trial.

- ✓ Indicate the Dog's sex, height (close if dog hasn't been measured yet), breed (All American is the indication for mixed breeds), and call name.
- ✓ The AKC Number is critical; this is how your dog's performance record is tracked – make sure to double check this when you get your confirmation from the Trial Secretary. Enter date & place of birth (USA or country).
- ✓ If you know the following, enter Breeder, Sire and Dam. If dog is an All American, just put unknown.
- ✓ Enter Actual Owner, Address, City, State & ZIP. This is where AKC will send your title certificates. If the owner is not handling the dog (or if multiple owners), enter the handler's name.
- ✓ On the second page, read the Agreement & Instructions. If a Junior Handler, enter JH Number so that they get proper credit towards college scholarships. Be sure to sign the entry.
- ✓ Enter your cell # (this is how we will contact you during the trial if there is a need). Your email address is critical as this is how the Trial Secretary will communicate with you prior to and after the trial.
- ✓ Give us an emergency contact – we don't want to use it but is critical if there is an emergency with you or your dogs.
- ✓ If you have questions – be sure to contact the Trial Secretary – that is what they are there for and it is easier to fix a question prior to the trial!

# Agility Rules and Competitor Reports!

There have been many cases in the last few months of a dog & handler team losing hard earned legs due to not completing the requirements for the lower level title. This should help resolve these issues!

**Agility Rules & Regulations:** It is difficult to compete in a sport if you don't know all the rules. AKC has a way to download the rules at no charge.

## Go to AKC.org:

- Select Sports & Events tab.  
Select Rules & Regulations.  
Select Sports.
- Select Agility Trial
- Regulations. This will download a .pdf of the rules. Be aware that if you print it, you will use a ton of toner as it is set up as a bifold & only prints as a single page.

## Your record of accomplishments.

You don't know for sure if you have completed a title until AKC records it. We have three different exhibitors that AKC has made a mistake on recording their legs toward titles. Due to the exhibitor knowing to ask about it, we were able to get it corrected.

## Go to AKC.org. Products & Services tab.

- Select AKC Competitor Reports
- Select Individual Dog Record & Products for your dog.
- Select Find A Dog. Enter your dog's AKC Registration number and hit search. Click
- the link to "Use this dog for all your reports".
- Select View Points/Summary of the Title Progression for this dog. Your dog's record will display. Be aware that if you have recently completed leg(s), they may not have processed yet. AKC takes about 4 weeks to process a trial's Points Report

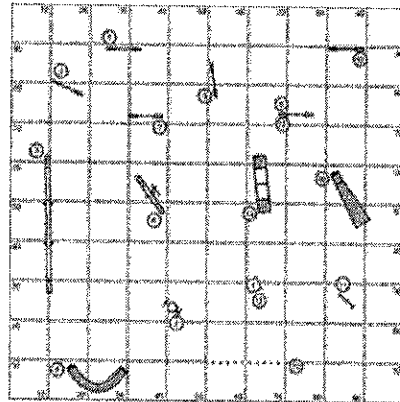
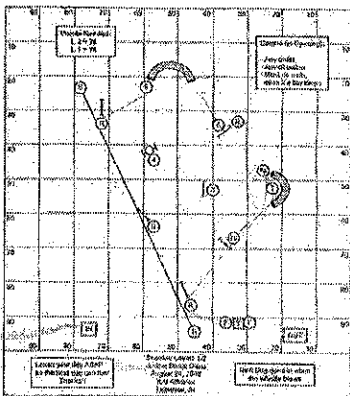
## Working for your Club at the Agility Trial, or wondering if you are ready to work?
