2020 TVKC Agility brought us an unexpected pandemic to work around and avoid. Following CDC (Centers for Disease Control and Prevention), State of Alaska and AKC recommended guidelines we successfully held

five weekends of trials.

Thanks to the tireless efforts of many individuals who worked overtime to ensure that we could provide a safe environment for all involved. We received permission from AKC to have volunteer substitutions for AKC judges that were unable to travel to Alaska.

After postponement of our April and June trials, we held our 4th of July trial at the fairgrounds with Michaela Krohn and Chris Terzi volunteer judging under very sunny skies. The June trial was moved to August 1-3 with AKC judge Mike Teh stepping in to travel to Alaska on short notice. This trial was held for the first time at the Ester Community Park which had grounds that were a real treat to run on. Our postponed April trial was held at the fairgrounds August 21-23 with AKC judge Geoff Nieder. The September trial was moved from indoors at Camp LiWa to outdoors at the fairgrounds with volunteer judges Shonda Oderkirk, Chris Terzi and Rob Peterson. Although the mornings were cool and frosty, each day ended up being sunny without rain or snow! Our last trial of the year was held indoors at Camp LiWa with volunteer judges Michaela Krohn and Shonda Oderkirk.

In addition to self-judging, many other familiar aspects from years past were altered so that social distancing could be maintained. Some changes allowed for

smoother running of the trials and will likely be kept for future events. One such feature was the addition of the "Agility Gate" app. Participants downloaded the app onto their phones, checked their dog(s) in and then followed the app from their tents or vehicles so they would know when their turn was close. This app allowed for smooth check in without congestion at the gate.

Safety at these trials for all was of utmost importance. Cooperation with mask wearing and sanitization was greatly appreciated. With a tremendous amount of thought and planning, TVKC agility set the bar high in order to ensure the safety for all involved. We are grateful for the consultation and guidance from AKC's Director of Agility Carrie DeYoung. Carrie was very supportive as we planned to make our agility season safe and successful. In addition, special thanks to the following for the extra time and effort this past season; trial chairs Linda Schertz, Nicki Stewart and Michaela Krohn; trial secretaries Terri Morefield and Kimberlee Beckmen, and volunteer judges Michaela Krohn, Chris Terzi, Shonda Oderkirk and Rob Peterson.

Thanks to the cooperation of everyone, the Fairbanks agility trials in 2020 were declared a success! TVKC has an amazing team - from volunteer coordinators to course builders to setup/takedown and trial volunteers.

The TVKC Tracking Committee, in August, 2020, held its 41st TDX and TD Tests in the Chena Flood Control Plain, plus it's 19th VST and 4th TDU. Testing was located in various Fairbanks urban locations. Judges were Mr. Jeffery Shaver and Mrs. Francis Keays. Here is a summary of

the tests presented, along with the challenges and results.

TD = Tracking Dog. Six dog teams were tested for TD (approx. 500 yards in simple vegetation). Three passed from Fairbanks, and two passed from Anchorage.

TDX = Tracking Dog Excellent. Five dog teams were tested for TDX (approx. 1,000 yards in changing vegetation with cross tracks). Two passed from Fairbanks, and one passed from Palmer.

TDU = Tracking Dog Urban. Two dog teams were tested for TDU (approx. 500 yards in various urban surfaces, such as grass and pavement). None passed. There were two alternates entered, but none were tested.

VST = Variable Surface Tracking. Six dog teams were tested for VST (approx. 1,000 yards in various urban surfaces, such as grass and pavement). None passed. There were three alternates entered, but only one was tested.

Tracking Test Committee worked very hard to make these tests happen as scheduled, and were often challenged and as the 2020 test year was different and difficult in several ways from previous years (mainly due to COVID) ::

Here are some of the many challenges which required tough choices and determination:

- • Two judges that had signed contracts backed out due to COVID.
- It was generally decided that the judges would stay in a hotel as opposed to someone's home. A similar choice was made ffor ground transportation (rental car, not a loaner).
- The Army Corps. of Engineers refused to give the committee a key to vehicle gates, which greatly inconvenienced the judges, tracklayers, exhibitors, helpers, and observers.
- The University of Alaska refused to allow us on the campus (at the last minute), which inconvenienced everyone.
- The venue situation really put a damper on any gallery of spectators and interested parties.
- • Financially, the testing cost more than what was budgeted

On brighter notes, we had a two-day Scent Work seminar-workshop by Deb Gillis, in Dianne Marshall's wonderful big building, prior to the tracking tests. Ten dog teams participated, had a lot of fun, and learned various skills. With doors and windows wide open, masks worn by everyone and social distancing observed it was a very safe environment. This seminar-workshop broke even financially.

We also had a one-day Tracking seminar-workshop by Jeffery Shaver. This was very informative for both new and seasoned handlers with their dogs. Working in the great outdoors, practicing safe measures, allowed this to also be very safe as well. This seminar-workshop broke even financially.
